The Company shall have the right to cancel this agreement without any liability when issued in error or for non-payment. The decision as to whether to repair or replace parts rests solely with the Company.
- The Company shall not be responsible for failure to perform service or furnish parts due to any or all causes beyond its control and shall in no event be responsible or liable for consequential or indirect damages or any other damages, due to cause beyond its control.
- The Company will not assume any responsibility and this agreement shall be null and void, if equipment is serviced by anyone other than authorized company personnel.
- The services rendered are limited to the parts and services shown or described herein. Charges will be made for all other parts and services.
- Obsolete units and obsolete parts are not covered under this plan.
- All service agreements will expire on the anniversary date one year from start/renewal date.
- Company responsibility is specifically limited to the items set forth herein.
